 - Guidelines pertaining to National Apprenticeship Promotion Scheme-2 (NAPS-2. Copy enclosed.

Any discrepancy or information regarding false documents in supporting documents, if comes to the notice of the Ministry, the empanelment will be cancelled. If any of the TPA is found to have association in any form with any blacklisted TPAs, their empanelment will be rejected.
